PKB/AO-77/2010 under section 15-I of SEBI Act, 1992 read with rule 5 of SEBI Rules, 1995 in respect of Mr. Manmohan Shetty hereby referred as ("Noticee") being the founder of Adlabs Films Ltd. ("Company") incorporated in the year 1978. The company's Board meeting dated April 23, 2006 convened to approve Audited accounts,



recommend dividend, and consider proposal for demerger of Radio business. Pursuant to the approval of the BOD, the company informed the respective exchanges about the same and was disseminated at the website. It was further observed that the noticee had sold 10,00,000 shares of the company at the average rate of Rs. 402.60 per share on April 24, 2006 through the broker Gupta Equities Pvt Ltd. on BSE. The noticee was believed to be benefited by selling the shares before the expiry of 24 hours of the BOD outcome and in suspicion of insider trading. Hence an inquiry was held, the inquiry imposed an order with monetary penalty of Rs. 100,00,000/- which is required to be paid through a demand draft within 45 days of receipt of the order
